## YOU MAY BE EXPERIENCING COMMON REACTIONS TO AERIAL SPRAYING

**460 + people reported symptoms from being sprayed, and many more reacted without filling out any reports.** Many people complained that their medical physicians refused to report to the county even though law requires it. Not knowing how to recognize toxicity caused by the spray may be part of the problem. It's important to fill out the forms and report your adverse reactions. Even if your physician does not recognize toxicity – CASS & The EPA want to hear from you! WARNING: Symptoms change over time and persist. The chemicals take 30-90 days to degrade. If you think you have been exposed or know that you have been made ill from the spray please report your adverse reactions to;
